- **Report from PNC** Rick Barton reported that the Pastor Nominating Committee is meeting weekly to evaluate candidates' Personal Information Forms
- Treasurer's Report January income \$70,062; expenses \$46,820
- Finance & Stewardship planning mid-year meetings
- **Children, Youth & Family** the pancake supper made \$1,162; a spaghetti luncheon is planned for a Sunday in mid-March; working on plans for Vacation Bible School
- **Mission** volunteers are needed to provide lunches for Habitat workers; the Benevolence fund is under budget; they moved \$500 to PDA
- **Building & Grounds** The Adopt a Bed program is going well. Work on the shed is ongoing. The Moore St. sign needs to be replaced
- Administration & Communication On March 12 and 26 there will be tutorial sessions on using the new website during fellowship time. E-cards are being sent for birthdays. Records are retained on the website. Reported that there had been a request that the Session, Board of Deacons, and individual committee members' photos appear on the website. There was consensus that photos on the online church directory were sufficient.
